Cataloging

- Get the authority system ready to do authority and bib exports/imports -- IN **PROGRESS MIKE!**
 - batch bib and authority loading interfaces (that a librarian sys-admin type would feel comfortable with)
 - overlay
 - identify non-matching records for manual overlay or import
 - import
 - identify conflicting records for manual overlay or alternate TCN import
 - batch bib and authority export interfaces (ditto) (see here)
 - phase 1: input is bib/authority system IDs, output is user+date named MARC file for download
 - low level export service
 - basic record-bucket exporter for bibs
 - phase 2: how to create such a list of IDs... (by October 8) -- CSV file containing bib or authority IDs from an EG report
- Create New MARC records (sound recording and video recording format).

- Longoverdue; moving items over to long overdue after 180 days. Per system or PINES-wide. PINES-wide already available. (The script itself is pretty much done-- per library basis? PINES-wide?) Elizabeth

Holds

- Interface for entering mailing labels addresses -- doesn't this exist in the bootstrapping interface? (We need libs to add/maintain this data) --> libs needs to be able to edit it themselves (Elizabeth will send mockup of mailing labels)
- Hold suspension
 - staff ability to disable all holds for a patron (what about new holds? auto-freeze? dissalow?)
 - expiration functionality (policy-based expire interval)
 - staff client interface for managing freeze/thaw of patron holds
 - patron freezing in single or batch with thaw date
- Hold Expiration Date- subcomms will decide if 6 months is default- (to be determined at Feb 13 Exec Comm Mtg)
 - need a way to be alerted (library staff and in patron account) when item is nearing expiration
- Change wording on Holds notices: add "Contact your local library to determine how long this item will be held for you." - BILL (added, needs config update on prod and restart)
