# Proposed circulation modifier reorganization 2021

Proposed new Circulation modifiers:

audiobook-ff (use currently restricted to pilot libraries) video-0 video-2 video-2-ff (use currently restricted to pilot libraries)

Proposed Circulation modifiers to be removed from PINES configuration

Currently, PINES circulation modifiers for audiovisual materials are a combination of format and content. I am proposing changing the format-based circ modifiers to content-based ones. Creating these new circulation modifiers and retiring the format-based ones would lessen the number of circulation modifiers used by PINES libraries by eight. It would prevent the need for the creation of additional circ modifiers if a new format for these materials is created in the future. It would also streamline entries in the annual report since all PINES libraries would use the same circulation modifiers for the categories counted in the report.

Circulation rules would be inherited by the new circulation modifiers. Fines-free circulation modifiers currently restricted to pilot libraries would remain restricted.

Under this proposal, the circulation modifiers for audiovisual material would be:

Nonmusical sound recordings. Can be audiocassettes, compact discs, MP3 players or other nonprint physical media designed to be played back on an audio device. A 007 field should be included in the MARC record to define specific type. Not holdable outside owning library system.

### audiobook-ff

Nonmusical sound recordings. Can be audiocassettes, compact discs, MP3 players or other nonprint physical media designed to be played back on an audio device. A 007 field should be included in the MARC record to define specific type. Not holdable outside owning library system. Accrues no fines. Use is currently restricted to libraries participating in the pilot project to determine feasibility of being fines free.

#### music

Music sound recordings in any format. Can be audiocassettes, compact discs, MP3 players or other nonprint physical media designed to be played back on an audio device. Not holdable outside owning library system.

#### music-ff

Music sound recordings in any format. Can be audiocassettes, compact discs, MP3 players or other nonprint physical media designed to be played back on an audio device. Not holdable outside owning library system. Accrues no fines. Use is currently restricted to libraries participating in the pilot project to determine feasibility of being fines free.

#### video-0

Projected video/media on any physical format. A 007 field should be included in the MARC record to define media format. Items with this circulation modifier are not renewable. Not holdable outside owning library system.

### video-2

Projected video/media on any physical format. A 007 field should be included in the MARC record to define media format. Items with this circulation modifier are renewable twice. Not holdable outside owning library system.

## video-2-ff

Projected video/media on any physical format. A 007 field should be included in the MARC record to define media format. Items with this circulation modifier are renewable twice. Not holdable outside owning library system. Accrues no fines. Use is currently restricted to libraries participating in the pilot project to determine feasibility of being fines free
